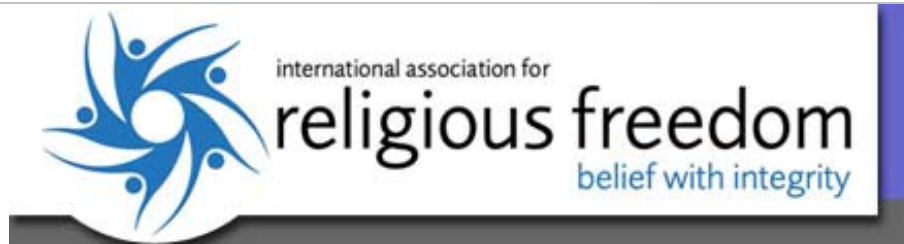

## Letter of Protest Sent to UU World

Members and Friends!

I submitted the following letter to the *UU World* magazine in response to the article, "UUA Charts New International Course," which appeared in its Summer 2009 issue.

September 7, 2009

To the Editor of the *UU World*:

*It is sad and discouraging to read "UUA Charts New International Course" in the recent UU World and to know that the new international course will include only \$500 for the work of the International Association for Religious Freedom (IARF). The decision to cut funding from \$30,000 to \$500 was not news to me since I have seen the continual decrease in support for the IARF beginning with the time I served as the UUA Board Trustee from the Mass Bay District. Beginning with the former UUA President John Buehrens and continuing with the presidency of Bill Sinkford, the UUA opinion has been that the IARF does not serve our congregations, it is "less oriented to Unitarian Universalists," and therefore money should be directed to the work of the Partner Church and the International Council of Unitarian Universalism (ICUU). There is no doubt about the value of these organizations but I cannot understand the reason to cut off financial support to this unique and historical international and inter-religious connection we have as Unitarian Universalists.*

Certainly there are local interfaith groups but the IARF is rooted in the motivation of and was founded by Unitarians over 100 years ago to establish ongoing relationships with other religious groups around the world. At this time when there continues to be misunderstanding among the world's religions, it is not the time for the UUA to chart a "new international course" without including the IARF. The unique relationships of IARF members and friends extend beyond the United States and Unitarian Universalism to Europe, India, Japan, Africa and Asia. This is the gift of IARF, to promote and sustain interfaith personal relationships. I hope that President Morales with his challenge to us about religious diversity and the UUA Board of Trustees will consider charting a new international course with renewed support of IARF as an equal partner.

## Religious Freedom Status in the U.S.

Despite many hopes to the contrary, after almost a year into the Obama administration, the "enmeshment" of religion and politics or religion and government continues with explicit or implicit support and approval of the new administration.

The Faith-Based Initiatives are continued and the government funding of them is expanded. The Offices or Centers of Faith-Based Initiatives have been established in the White House and numerous federal offices and departments. Even if we gloss over the fact that the majority of the funding is awarded to evangelical Christian churches and organizations, which openly discriminate and proselytize, the entire faith-based enterprise clearly creates an impression that the government makes a preference of religious belief over non-belief.

Another recent example of how firmly Christianity is "entrenched" in the US Armed Forces and taken for granted as the "national religion," is the address delivered by U.S. Army Chaplain (Col.) Thomas MacGregor, on D-Day, June 6, 2009, concluding his invocation with reference to the second coming of the Lord when all wars would cease. Imposition of a religious and overtly Christian ritual upon a diverse audience in the name of and on behalf of our entire country, and in the presence of the President of the United States, who publicly joined in this prayer, speaks poorly of our commitment to uphold the principles of separation of church and state.

On the bright side, a Federal District judge has refused to dismiss a Court case challenging the legality of the National Day of Prayer proclamations. Denied were motions to dismiss filed by defendants Pres. Barack Obama, press secretary Robert Gibbs, Shirley Dobson, of the National Day of Prayer Taskforce, and Pat Robertson's legal arm, the American Center for Law and Justice.

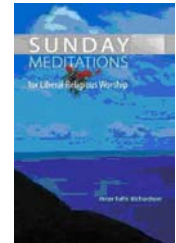
There is still much to be done in the United States to promote and protect freedom of religion.

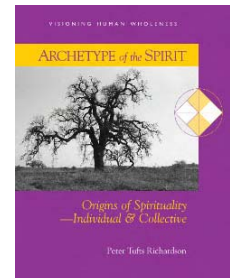
### Sunday Meditations for Liberal Religious Worship
